### **FELONY DRUG WARRANT ARREST**

**SATURDAY MAY 5TH, 2012**



ON THURSDAY MAY 3<sup>RD</sup>, 2012, AT 4:45 PM, A SAN BENITO POLICE K-9 OFFICER WHILE ON PATROL OBSERVED A WANTED MALE SUBJECT IDENTIFIED AS 20 YEAR OLD JACOB BARRIENTOS TRAVELING IN A GREY IN COLOR SEDAN WITH TEXAS LICENSE PLATES BY THE INTERSECTION OF ROBERTSON ST. AND COMBES. THE K-9 OFFICER THEN CONDUCTED A TRAFFIC STOP ON THE PASSENGER SEDAN, AND MADE CONTACT WITH JACOB BARRIENTOS WHO WAS ADVISED THAT HE WAS WANTED ON SEVERAL FELONY WARRANTS. THE OFFICER ATTEMPTED TO PLACE JACOB BARRIENTOS UNDER ARREST BUT HE RESISTED, AND SBPD NARCOTIC DETECTIVES ARRIVED TO ASSIST IN PLACING THE HIM UNDER ARREST. A SEARCH REVEALED THAT THE MR. BARRIENTOS WAS IN POSSESSION OF CONTROLLED SUBSTANCE AS WELL AS DRUG PARAPHERNALIA. MR. BARRIENTOS WAS TRANSPORTED TO CITY JAIL WHERE HE WAS BOOKED IN ON THE FOLLOWING CHARGES: MANUFACTURING/DELIVERING CONTROLLED SUBSTANCE PG-1 STATE JAIL FELONY, MANUFACTURE/DELIVERING CONTROLLED SUBSTANCE PG-3 STATE JAIL FELONY, POSSESSION OF CONTROLLED SUBSTANCE PG-3 (DRUG FREE ZONE) STATE JAIL FELONY, RESISTING ARREST CLASS A MISDEMEANOR, EVADING ARREST ON FOOT CLASS A MISDEMEANOR AND POSSESSEION OF DRUG PARAPHERNALIA CLASS C MISDEMEANOR. JUSTICE OF THE PEACE DAVID GARZA ARRAINGED MR.BARRIENTOS AND HE SET BONDS ON ALL CHARGES AT A TOTAL OF \$150,000.00 DOLLARS. MR. BARRIENTOS IS CURRENTLY AT THE CAMERON COUNTY JAIL.
