PRESS RELEASE



ON 03-22-2012, SAN BENITO POLICE OFFICERS RESPONDED TO THE 100 BLOCK OF LOLITA STREET IN REFERENCE TO A DISTURBANCE. UPON ARRIVAL TO THE LOCATION A FEMALE REPORTED THAT HER HUSBAND AND SON, WHO WAS LATER IDENTIFIED AS 40 YEAR OLD REYNALDO BOCANEGRA JR, HAD BEEN INVOLVED IN A FIGHT WITH EACH OTHER. BOCANEGRA JR IS ALLEGED TO HAVE ASSAULTED HIS FATHER AND NEPHEW BY PUNCHING HIS FATHER AND STRIKING HIS NEPHEW WITH A METAL OBJECT ON THE ARM. BOCANEGRA FLED THE LOCATION AND WAS CAUGHT A SHORT TIME LATER IN THE AREA. BOCANEGRA JR WAS TRANSPORTED TO THE SAN BENITO CITY JAIL. DURING THE TRANSPORT BOCANEGRA JR KICKED THE REAR WINDOW TO THE POLICE CAR CAUSING DAMAGE TO THE WINDOW. BOCANEGRA JR WAS CHARGED WITH 2 COUNTS OF ASSAULT FAMILY VIOLENCE WITH PREVIOUS CONVICTIONS WITH IS A 3RD DEGREE FELONY, BOND WAS SET AT \$15,000 EACH, AND CRIMINAL MISCHIEF CLASS B FOR THE DAMAGE TO THE POLICE CAR, BOND WAS SET AT \$5,000. IT WAS DISCOVERED THAT BOCANEGRA JR HAD SEVERAL OTHER WARRANTS FOR HIS ARREST. CRIMINAL MISCHIEF CLASS B WARRANT # 2012IMG000057 BOND WAS SET AT \$10,000 FOR AN INCIDENT THAT OCCURRED ON MARCH 3, 2012 ON THE 1100 BLOCK OF COMBES AND TWO WARRANTS WERE OUT OF THE CAMERON COUNTY DISTRICT COURT. ONE WAS FOR ASSAULT FAMILY VIOLENCE WITH PREVIOUS CONVICTIONS 3RD DEGREE FELONY, \$5,000 BOND AND FOR POSSESSION OF MARIJUANA CLASS B MISDEMEANOR, \$7,500 BOND. HE IS CURRENTLY IN THE CUSTODY OF THE CAMERON COUNTY JAIL.
